

## ORDINANCE NO. 581-2021

**AN ORDINANCE OF THE CITY OF ELECTRIC CITY, WASHINGTON, AMENDING SECTION 8.05.210 RATE SCHEDULE OF THE ELECTRIC CITY MUNICIPAL CODE CHAPTER 8.05 GARBAGE, AND REPEALING ORDINANCE 527-2017, INCREASING THE SCHEDULE OF CHARGES FOR THE COLLECTION AND DISPOSAL OF GARBAGE.**

**THE CITY COUNCIL OF THE CITY OF ELECTRIC CITY, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1.** Pursuant to Section 8.05 of the Electric City Municipal Code, the following rates are hereby established for the collection and disposal of solid waste within the corporate boundary of the City of Electric City.

**A. Residential Service:**

These rates apply to all single-family residences. One pickup per week collection of garbage and refuse properly contained and placed by the occupant.

<b>Occasional Extra (per 35 gallon unit/Pickup)</b>	<b>\$6.85</b>

These rates apply to all TEMPORARY CONTAINERS PER WEEK. All residential containers are considered as temporary. All residential containers will have a Delivery fee of \$6.00 and a Pick-up fee of \$6.00 added to the rate – Total added: \$12.00.

**B. Commercial Service Collection:**

These rates apply to commercial businesses, which are defined as all other buildings, etc. other than a single-family residence and as defined in Section 8.05.010. Minimum of one pickup per week, collection of garbage and refuse properly contained and placed by the occupant. The minimum charge per each business or commercial account shall be \$30.22 (thirty dollars twenty-two cents) per month.

Occasional Extra (per 35 gallon unit/pickup)	<b>\$6.85</b>

**Container Garbage Collection:**

The rate for handling of detachable containers, approved by the City and the City's Contractor for use by commercial and industrial businesses for minimum of one pickup per week shall be as follows:

Commercial 1 yd	<b>\$94.29</b>
Commercial 1 yd Extra Pickup per month	<b>\$178.86</b>
Commercial 1 1/2 yd	<b>\$135.16</b>
Commercial 1 1/2 yd Extra Pickup per week	<b>\$164.40</b>
Commercial 2 yd	<b>\$172.52</b>
Commercial 2 yd Extra Pickup per week	<b>\$326.68</b>
Commercial 4 yd	<b>\$334.26</b>
Commercial 4 yd Extra Pickup per week	<b>\$404.60</b>
Commercial 6 yd	<b>\$495.84</b>
Commercial 6 yd Extra Pickup per week	<b>\$1,525.13</b>
Extra pickup Loose Yards Per Week	<b>\$24.29</b>

Monthly flat rental charge shall be included in the respective collection and disposal charge.

**Drop Box Garbage Collection:**

The fees for handling drop boxes approved by the City and the Contractor for use for special and temporary garbage/refuse collection shall be billed directly to the customer by the Contractor. Drop Box garbage collection is for ten yard containers or larger at unscheduled times or on call, which would vary the dispatch of the collection truck, personnel, and equipment.

**Compactor Garbage Collection:**

Customer furnished: The rate for handling compactors that compact garbage at a three-to-one or more ratio approved by the City and City's Contractor for use by commercial and industrial customers for a minimum of one pickup per month shall be as follows:

<b>Service Description (Per Pick-up Rate)</b>	<b>Haul Rate</b>
20-yard Compactor (does not include Special Pickup & Delivery Charge; Does not include Disposal Fee which is charged directly from Landfill)	<b>\$393.50</b>
30-yard Compactor (does not include Special Pickup & Delivery Charge; Does not include Disposal Fee which is charged directly from Landfill)	<b>\$449.67</b>
Special Delivery & pickup (Travel time for truck from Okanogan per hour for 20 & 30 Yd roll-off Containers)	<b>\$240.88</b>

The rates include collection and hauling only and do not include disposal fees charged by the Delano Regional Transfer Station (DRTS). The customer shall receive separate billing from the DRTS for disposal of refuse. All twenty and thirty-yard containers shall be billed Special Delivery & Pickup costs for travel from the contractor's main office in Okanogan to Electric City and back. Several customers at the discretion of the city can share the Special Delivery & Pickup charge.


**Section 2.** Ordinance No. 533-2018 is repealed.

**Section 3.** If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance is declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining parts of this Ordinance.

**Section 4.** This Ordinance shall become effective from and after its passage by the city council, approval by the mayor, and after publication by summary in the official newspaper of the city, as provided by law, and shall be implemented and applied commencing with March 1, 2021, billing period.
