

RESOLUTION No. 2019-31

A RESOLUTION ESTABLISHING WATER RATES AND REPEALING
RESOLUTION 2018-16

Recitals:

1. WHEREAS, by its adoption of Electric City Municipal Code section 13.05.190, the City Council of Electric City authorized the establishment and collection of rates, usage limits, connection fees, delinquent charges, and service charges related to water service both inside and outside city limits.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Electric City:


The following fees for water service are hereby established.

1. Residential Inside City Limits
The minimum monthly rate shall be ~~\$41.49~~ 43.99 for up to ~~10,000~~ 12,500 gallons.
Water usage from ~~10,000—30,000~~ 12,501-30,000 gallons will be charged \$.50 (cents) per 1,000 gallons
Water usage from 30,001 – 50,000 gallons will be charged \$.75 per 1,000 gallons
Water usage from 50,000-gallons will be charged \$1.00 per 1,000 gallons
2. Residential Outside City Limits
The minimum monthly rate shall be ~~\$47.97~~ 50.47 for up to ~~10,000~~ 12,500 gallons.
Water usage from ~~10,000—30,000~~ 12,501-30,000 gallons will be charged \$1.00 per 1,000 gallons
Water usage from 30,001 – 50,000 gallons will be charged \$1.25 per 1,000 gallons
Water usage from 50,001 gallons will be charged \$2.00 per 1,000 gallons
3. Bulk water sales will be charged \$12.50 per thousand gallons.
4. There will be connection charge of:
 - \$1,500.00 for up to a 5/8x 3/4 water meter
 - \$1,750.00 for a 1” water meter
 - \$2,500.00 for a 1 ½ “ water meter
 - \$3,100.00 for a 2” water meter
 - \$4,000.00 for larger than a 2 inch plus actual costs in excess of that amount including a 25% indirect overhead factor.
5. A 6% utility tax will be added to the above rates.
6. A penalty shall be assessed at the rate of \$15.00 per month on all delinquent utility bills.

7. A service charge of \$15.00 will be assessed for turning on any water service that has been turned off for failure to pay the utility bill.
8. An additional service charge of \$25.00 will be assessed during any hour other than 8:00 a.m. through 12:00 p.m. and 1:00 p.m. through 4:00 p.m. Monday through Friday for turning on any water service that has been turned off for non-payment.
9. The water rates stated in this resolution will commence on the January 1, 2019 2020 utility bill. ~~The minimum monthly rate will raise an additional \$2.50 commencing on the January 1, 2020 utility bill and an.~~ An additional \$1.00 will be added to the minimum monthly rate annually on January 1st thereafter until this resolution is amended or otherwise repealed
